July 16-17, 2011

NCWSA held a fun trial July 16-17 at the Willowside Ranch outside of Pescadero, CA. We offered Novice-Novice, Pro-Novice, and Ranch classes, in memory of Pam Cornell, owner of Willowside Ranch, who was such a generous resource to our sport.

Thanks to Yvette Cook, our super-efficient trial organizer; Rusty Jeffers, our judge; Glen and Sandy McGowan for their excellent and delicious camp kitchen meals and hospitality for the crew; Jennifer Stewart for organizing the setout volunteers; and Mimi Wilson, our friendly Course Director.

Of course many thanks to Willowside Ranch management for their help and cooperation in hosting this trial and preparing the field and sheep for our use.

Many handlers stepped in to help with setout, exhaust, clerking and other duties. Without all this help these trials would be impossible, so our heartfelt thanks go out to all of you!

The club and ranch management worked together to provide a safe working field and stock that worked well on the course. The porta potty had been delivered early. Combined with the cool overcast morning, the feeling was very positive that it was going to be a very good weekend.

On Sunday, there were discussions between handlers and Board at the handlers' meetings concerning the Club: directions it should take, need for new people to take on existing roles, novice needs and input, all of which was valuable information.

What is NCWSA? What does it offer me?

At our recent fun trial, we were asked by the handlers about the background and purpose of NCWSA. The following was written by Rusty Jeffers for another purpose and edited a bit to fit this space.

NCWSA's goal is to promote the sport of trialing. What we do primarily is sponsor trials and secondarily we represent the trialing community and donate funds to different sheepdog related causes and events. Although we primarily put on USBCHA sheepdog trials, we support the herding community in general. We are a 501(c)3 tax-exempt organization.

The primary thing the club brings to the table for a trial is financial backing. If an individual wants to put on a trial, they supply the ranch, facilities and livestock and hope entry fees are enough to cover expenses and leave some left over to cover the use of their facilities. When the club sponsors a trial, we pay the ranch owner a contracted amount for rental of the facility and a contracted amount for the livestock. The bottom line is the ranch owner and stock provider are given a guaranteed amount of money and the financial risk is borne by the club.

Along with the financial risk of running the trial is the insurance risk should someone be injured at the trial. The club has liability insurance to cover this and when we rent a facility, we name the facility owners on our policy to help cover their interests in the event something unfortunate happens. This is rightfully a very important concern on the part of ranch owners.

The club also has trial equipment, what we like to call a "sheepdog trial in a box". It's a

trailer with panels, pens, tarps, t-posts, EZ-ups, coffee maker and all the little things you need to put on a trial. In addition we have specially designed set-out pens which are 8 feet long to fit in the bed of a pickup. With one full-size pick-up we can move all this equipment to the trial venue. We have done a number of fundraisers over the years to purchase this equipment and it has done big tours of Northern California.

We also supply some expertise. When someone approaches us to put on a trial, we require that they submit a budget and trial plan which includes a listing of personnel for key positions. Only after these items pass the review of the club board of directors, will the club sponsor an event. Once the club signs on to a trial, the trial committee has access to club members to recruit to work the event.

Fund raising: with our tax-exempt status, we can approach businesses and people for donations and we are even sometimes the recipient of unsolicited donations. Almost all of our events have had raffles and those have become key parts of trial financing.

The club brings credibility to an event. When we approach a ranch owner, stockman and others about a trial, we are an organized club with financial statements, insurance, and a history of successful events which can help ease the mind of someone considering holding a trial at their facility.

We have a board of directors, and the secretary and treasurer jobs do take some time. One major annual cost is Directors & Officers Insurance (D&O). This protects the officers of the club should anyone think to sue them for their actions as an officer.

Nominating Committee and 2012 Board

We're looking to complete a Nominating Committee to help to fill the officers' slate for 2012. One person has volunteered, but I hope to find one other individual to help. If you are willing to serve on the Committee (or on the Board), please contact me at:

The Committee members will contact people personally to find willing participants to run for election to the board. Normally these board positions do not take a lot of time and we will provide mentoring and transition for new people. Here is a chance to make your voice heard! Thanks!

Novice FAQ

We're starting a new column—"Novice FAQ" — that will help to answer Novice handlers' questions and concerns about trialing. (The first two questions were generated by or at the Willowside fun trial.) Q: How do I know when to send my dog from the post? Will the setout person signal to me?

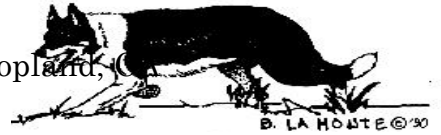
A: No the setout people will not signal to you. They will be quietly holding your sheep with their dog(s) as calmly and settled as they are able. It is each individual handler's responsibility to decide what moment to set their dog into action from their side. Generally you do not want to send too soon (before the sheep are moved to the proper position and settled); but you also do not want to wait too long. It can be hard for setout to hold the sheep and can also build up unnecessary tension in your dog to lie there and wait. In most cases, you want to allow your dog to see the sheep brought out from the holding pen and settled and then send your dog from the post as soon as the sheep are still (and not much longer). You also must learn to know your own dog and what works for him/her the best. Your "setout and send" routine is something that should be practiced along with everything else that you do in your training. Good luck!

Q: If my dog and I cannot drive yet, can I still run in Novice-Novice?

A: Yes—most novice classes do not require driving, but allow the handler to either fetch, assisted drive, or drive the panels to complete the course. Of course an outrun, lift, fetch, and pen are required skills in any Novice-Novice class.
