**Directions to trial site:**

10266 Victory Avenue, Oakdale, CA 95361

Located between Escalon and Oakdale just south of Hwy 120

From Manteca, take Hwy 120 East (Yosemite Avenue) approximately 10 miles East of Hwy 99 in Manteca. Turn right (South) on Victory Avenue and go approximately 1/3 mile. Look for gravel lane on the left, and sheepdog trial signs.

From Oakdale, go West on Hwy 120 to Victory Avenue and turn left (South) and go approximately 1/3 mile. Look for gravel lane on the left, and sheepdog trial signs.
