This is a casual, low-key and FUN, one-day Event.

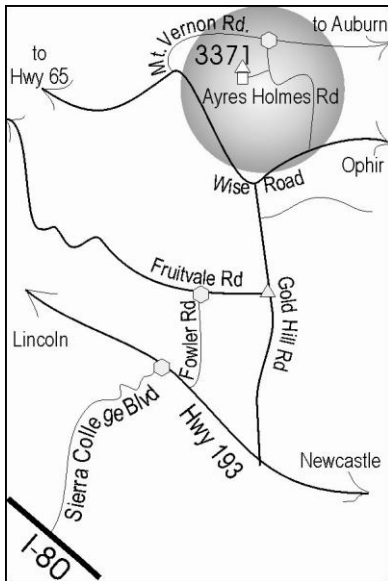
ENTRIES open **February 1st** space is limited, Entries taken until **February 15, 2012** or until limit is met.

Novice-Novice: \$20 --Two Runs. Course: 100 yd. Outrun, lift, fetch, walk/drive one panel, hold sheep.

Course Director: Virginia Dains **Judges:** Peer Judging –scoresheets & comments **Prizes!Prizes!Prizes**

Both classes will run on a rolling, partially fenced field, using a mix of dorperX sheep, Barbados, and young goats. Bring your own everything -- deli/restaurants/grocery 20 minutes away in Newcastle, Auburn, or Lincoln. Event will be canceled if heavy rain is forecasted for Sunday. At Dead End Turn Right on Fruitvale Road. At Dead End Turn Left on Gold Hill Road. Take Second Right, Wise Road. First Left on Ayres Holmes Road.
