**Directions:** South on Highway 1 from San Francisco (or you can take Hwy 280 and go west on Hwy 92 to Half Moon Bay, then South on Highway 1) to Pescadero Road; turn left on Pescadero Road and go into town to flashing red light at Stage Road; turn left on Stage Road; go 2 1/2 miles to sharp bend in the road (with a white house, blue trim directly ahead); this is Willowside Ranch. Turn right to get into the barnyard; you'll have to open and CLOSE the gate!!
